Reservations for the entire **2026/2027 School Year** begin online at **9:00 a.m.** on:

**Tuesday, May 12th, 2026** - “Southern California”  
*Orange, San Diego, Imperial*

**Wednesday, May 13th, 2026** - “Southern California part 2”  
*Los Angeles, Riverside, Ventura, & San Bernardino counties*

**Thursday May 14th, 2026** - “Northern California”  
*All remaining counties throughout the state*

**Friday May 15th, 2026** - “New Schools & Waitlist”  
*Any first time school in any county and the waitlist opens*

*The split start dates of different counties will not affect the calendar availability in your area.*

- ▶ Use your existing online account or create a new one and follow the instructions to reserve from the available dates in your area. If you do not have an account or have changed schools, be sure to create one or edit your school prior to opening day.
  - \* *The online reservation can only be accessed by the person creating the account. If you will not be available during the 2026/2027 school year to access the reservation, please have another school staff member who will be available make the reservation. All communication for the Walk Through goes through this person.*
  - \* *Once logged in, you will be placed in a virtual waiting room by order of entry. Wait times can vary. If you log in before 9:00am, you will not “skip the line” or get early access as the entry time will randomize anybody in the waiting room.*
  - \* *Please consider using an **alternate e-mail address** to create a new account if you have found it difficult to receive messages through your district provided e-mail address.*

Once you have completed your reservation you will receive a confirmation of your dates by e-mail along with a Pro-Forma invoice to use for billing (make sure to check your spam folder if you don't receive it). All processed invoices will be sent through email and regular mail at a later date.

Log in to the online reservation system to see your existing reservation(s), to schedule any additional *Walk Through Presentations*, update your Itinerary Details, or to update your contact & billing information.

*Please note that we cannot schedule Walk Through Presentations by mail, e-mail, fax, or phone.*

- ◆ DATES ARE ASSIGNED BASED ON A FIRST-COME, FIRST-SERVED BASIS USING OUR ONLINE RESERVATION SYSTEM.
- ◆ YOU MAY CANCEL OR CHANGE DATES UP TO **60 DAYS PRIOR** TO SCHEDULED PRESENTATIONS WITHOUT PENALTIES. **IF CANCELLATIONS OR CHANGES ARE MADE LESS THAN 60 DAYS PRIOR TO SCHEDULED PRESENTATIONS, YOU WILL BE RESPONSIBLE FOR THE FULL AMOUNT OF INVOICE ALONG WITH ANY OTHER APPLICABLE CHARGES.**
- ◆ INVOICES WILL BE SENT IN SEPTEMBER TO THE BILLING PERSON DESIGNATED BY YOU ON YOUR ONLINE ACCOUNT.

2. CANCELLATIONS AND CHANGES MAY BE MADE UP TO 60 DAYS PRIOR TO SCHEDULED PRESENTATIONS. IF ANY CANCELLATIONS/CHANGES ARE MADE LESS THAN 60 DAYS PRIOR TO SCHEDULED PRESENTATIONS, YOU WILL BE RESPONSIBLE FOR THE PAYMENT IN FULL OF THE ORIGINAL INVOICE.
3. A NON-REFUNDABLE PROCESSING FEE OF \$12.99 WILL BE ADDED TO ALL ORDERS/INVOICES. THIS FEE STILL APPLIES ONCE INVOICES ARE CREATED AND MAILED OUT & CANNOT BE REFUNDED, EVEN WHEN A SCHOOL CANCELS WITHIN THE 60 DAY POLICY. EXCEPTIONS TO THIS ARE ANY CANCELLATIONS MADE DURING MAY-JULY 2026.
